The Special Provision for “Item No. 0914005A - Reset Railing”, see special provision package Page 343, and plan Sheet No. 03.02.005 for details.

Q2. We have a question regarding Addenda 1 – on page 10 there are 6 Bid Alternates listed. Will the DOT provide Proposal Bid Sheets for these alternates?
