Scope of Work:

The project consists of site and landscape improvements for the Academic Quad area which is framed by Eastern Road, Webb Hall, Science Building, Constitution Hall, and the J. Eugene Library.

The Summary of Work includes but is not limited to the following:

- 1. Installation of sediment and erosion control measures.
- 2. Demolition activities of concrete walks, pavers, lighting and controls, site furnishings, and plant material.
- 3. Modification of existing utility and drainage systems.
- 4. Conduct grading operations.
- 5. Installation of decorative lighting and associated electrical work.
- 6. Installation of an irrigation system.
- 7. Installation of new sidewalks, pavers, staircases, stonewalls, site furnishings, decorative lighting, and landscaping

Prevailing wage rates apply. This project is subject to the state set aside goals of 25% SBE, of which 25% must be contracted with a CT DAS certified MBE vendor.

The project <u>is</u> subject to Pre-Qualification of Contractors Pursuant to CGS. ss4a-100. The prequalification classification/s for this project shall be "General Building Construction (Group A)".
