2. Section 1.1 shall be modified, in part, as follows:

1.1 NOTICE. Notice is hereby given that The Metropolitan District (MDC) is inviting companies to submit bids on Contract Number 2014B-17 to provide rehabilitation, upgrades and onsite services for centrifuges and related systems, as specified in this solicitation. **Sealed bids will be received by the MDC no later than 2:00 p.m. Eastern Time on October 16, 2014** at the Office of the District Clerk, as specified
