The project consists of:

The rehabilitation of Bridge 05355 at Bradley International Airport in Windsor Locks, Connecticut. The work includes replacement of all bridge joints, repairs to existing bridge drainage, patching of spalls, reconstructing concrete column encasement, and a weld repair.

The contract time for completion of all work is within **one hundred thirty (130) calendar days** from the date specified in the "Notice to Proceed".

The work performed under this Contract **WILL NOT** be governed by Federal Contract Provisions, since federal funding will not be used. However, the attention of prospective bidders is called to the fact that this project is to be bid upon and the contract executed, under the Federal Rules and Regulations for carrying out the provisions of:
