The Town of Vernon, Connecticut is seeking an Architectural firm to provide design services for the preparation of plans and construction documents for a partial roof replacement at Vernon Center Middle School during the summer of 2018. The total project includes replacement of approximately 65,195 square feet of roof. *Note that a mandatory site visit will be held at Vernon Center Middle School, 777 Hartford Turnpike, on Wednesday, January 24, 2018 at 2:00 PM.* 

All respondents shall provide three (3) hard copies and one (1) electronic copy of proposals and should be submitted in a sealed envelope, clearly marked "BID DOCUMENT – RFP/RFQ #2025-02/08/2018 - Architectural Design Services - School Roof Replacement" on the outside of the envelope, to:

Qualifications will be reviewed by the Town's Selection Committee. Interviews may be required. The selected firm must meet all municipal, state and federal Affirmative Action and Equal Employment Opportunity practices and requirements. MBEs/WBEs/SBEs are encouraged to apply.

The Town reserves the right to reject any or all applications in whole or in part, to award any one service or group of services or all services, to negotiate with any or all companies submitting qualifications, and to enter into an agreement with any company for any services mentioned in this RFP/RFQ if it is deemed to be in the best interest of the Town.

# **PROJECT DESCRIPTION - SCOPE OF SERVICE**

A partial roof replacement at **Vernon Center Middle School**, located at 777 Hartford Turnpike, Vernon, CT. The total project includes replacement of approximately 65,195 square feet of roof.

The work will include:

- Full representation through the Office of School Construction Services review process (DDR and the Pre-bid construction phase).
- Assessment of the structural condition of the roof and verify that it is structurally sound under current code requirements
- Participation in the roofing contractor scope review and selection process.
- Hiring of any consultants required to complete the job and review of all submittals.
- On-going inspection of the roof as the installation progresses to ensure compliance with the specifications.
- Review of all invoices for accuracy prior to submission to the client.
- Development of the punch list.
- Final inspection and acceptance of the project as complete.

# **Project Deliverables**

- Drawings, specifications, and any associated technical data (calculations, suggested manufacturers' products, photographs, etc.) complete and ready for bidding.
- A proposed schedule for achieving the design goals within the master schedule proposed by the Town.

The architect is expected to be present for some or all of the meetings which may need to be conducted with user groups, either at the Architect's office, Town or Vernon, on site, or elsewhere (unlimited).

# **INSURANCE REQUIREMENTS**

All contractors and vendors are required to provide proof of the required insurance coverage before entering the premises or commencing any work at the Vernon Public Schools. Contractors and vendors must obtain, at their own expense, all the insurance required here from an insurance company A.M. Best rated as "A-VII" or better, and acceptable evidence of such insurance must be properly furnished to, and approved by, the Town

of Vernon. All subcontractors are subject to the same requirements. It is the responsibility of the primary contractor or vendor to obtain acceptable evidence of insurance from subcontractors.

The Town of Vernon also requires that they be named as an additional insured on your general liability policy(ies). Your general liability policy must be specifically endorsed with ISO Endorsement CG 20 10 (or equivalent) or ISO Endorsement CG 20 26 (or equivalent), and ISO Endorsement CG 20 37 (or equivalent). Where these forms require a description of locations or projects, enter "Vernon locations or projects." These form numbers must be specifically referenced on the certificate of insurance, and copies of these endorsements naming the Town of Vernon as additional insured must be furnished with the required certificate of insurance. If your insurance company uses a different form to provide the Town of Vernon with additional insured status on your policies, copies must be provided in advance with the insurance certificate for review and approval by the Town.

The amounts of insurance available to the Town as additional insured must be equal to the full policy limits carried by the contractor or vendor, including primary and excess (umbrella) liability policies or the amounts specified below, whichever is greater. Coverage provided under excess or umbrella policies must be at least as broad as that found in required underlying policies. All coverage must be primary and noncontributory as to the Town of Vernon.

The proper name for the entity to be named as additional insured is: "The Town of Vernon, and/or related or affiliated entities."

Evidence of compliance with these requirements is with the ACCORD form 25, "Certificate of Liability Insurance", plus copies of any required additional insured endorsements. Current insurance certificates must be furnished to the Town at all times. Replacement certificates must be furnished ten (10) days *prior to the expiration or replacement* of referenced policies. The Town of Vernon reserves the right to make commercially reasonable changes in these requirements during the term of any work or project.

#### **GENERAL TERMS AND CONDITIONS**

A prospective respondent must be willing to adhere to the following terms and conditions and by submitting a proposal hereby accepts and will comply with them in their response to this Request for Proposal.

- I. Acceptance or Rejection by The Town of Vernon Vernon reserves the right to accept and/or reject any or all proposals submitted for consideration to serve the best interests of the Town of Vernon. Respondents whose proposals are not accepted will be notified in writing.
- 2. <u>Ownership of Documents</u> All proposals submitted in response to this RFP are to be the sole property of the Town of Vernon and subject to the provisions of Section 1-19 of the Connecticut General Statutes (re: Freedom of Information).
- 3. <u>Ownership of Subsequent Products</u> Any product, whether acceptable or unacceptable, developed under a contract awarded as a result of this RFP is to be the sole property of the Town of Vernon unless stated otherwise in the RFP or contract.
- 4. <u>Timing and Sequence</u> Timing and sequence of events resulting from this RFP will ultimately be determined by Vernon.
- 5. **Oral Agreements** Any alleged oral agreement or arrangement made by a respondent with any agency or employee will be superseded by the written agreement.
- 6. <u>Amending or Canceling Requests</u> The Town of Vernon reserves the right to amend or cancel this RFP prior to the due date and time, if it is in the best interest of the Town of Vernon to do so.
- 7. **Rejection for Default or Misrepresentation** The Town of Vernon reserves the right to reject the proposal of the consultant that is in default of any prior contract or for misrepresentation.
- 8. <u>Clerical Errors in Awards</u> The Town of Vernon reserves the right to correct inaccurate awards resulting from its clerical errors
- 9. **Rejection of Submission** Submissions will be rejected in whole or in part if they limit or modify any of the terms and conditions and/or specifications of the RFP.
- 10. <u>Changes to Submissions</u>— No additions or changes to the original RFP will be allowed after submittal.

- II. <u>Contract Requirements</u> A formal agreement will be entered into with the firm selected. The contents of the proposal submitted by the successful respondent and the RFP will become part of any contract award.
- 12. **Rights Reserved to Vernon** the Town of Vernon reserves the right to award in part, to reject any and all proposals, in whole or in part, and to waive technical defects, irregularities and omissions if, in its judgment, the best interests of the Town will be served.
- 13. <u>Withdrawal of Submission</u> Negligence on the part of the respondent in preparing the RFP confers no right of withdrawal after the time fixed for the acceptance of the submission.
- 14. <u>Assigning, Transferring of Agreement</u> The successful respondent is prohibited from assigning, transferring, conveying, subletting or otherwise disposing of the agreement, its rights, title or interest therein or its power to execute such agreement to any other person, company, or corporation without the prior consent and approval in writing by Vernon.
- 15. <u>Cost of Preparing RFP</u> The Town of Vernon shall not be responsible for any expenses incurred by the organization in preparing and submitting a RFP. A RFP shall provide a straightforward, concise delineation of the firm's capabilities to satisfy the requirements of this request. Emphasis should be on completeness and clarity of content.
- 16. <u>Definition of Terms</u> For the purpose of this RFP, whenever the word "respondent" appears, it shall refer to "Architect" and whenever the word "Architect" appears, it shall refer to "respondent.
