ADDENDUM #1 RFP #2018-89

Truck Scale Replacement
Weigh Station – Transfer Station Facility

21st June, 2018 – It is intended that this Addendum incorporating the following corrections, revisions, additions, deletions and clarifications become part of the Contract Documents, including pricing as submitted.

General Questions:

1. Question: My company is concerned about the specified completion date of August 15, 2018. Due to recent tariffs on imported steel, the lead time has changed from 4-6 weeks to 12-16 weeks. Is the Town willing to extend the completion deadline date?

Response: Time is of the essence for this project and the Town reserves the right to award this project to the company that affords the Town with the most advantageous bid submission. Accordingly, the lead time on the delivery and the installation of the proposed new truck scale equipment may be a factor in this award. In the event that your proposed new truck scale equipment cannot meet the Town's August 15th, 2018 project completion date, please include within your bid submission an overview of your proposed services offer in the event that the existing truck scale is no longer functional and or operational. For instance, if your company is willing to provide the Town with an on-site temporary scale on or before the August 15th, 2018 timeframe; please include the specific details of such an offer with your bid submission materials.

2. Question: On page 3, item B.5, the new steel dead span is not specified as to the size and thickness.

Response: Include within your bid submission the size and thickness of the new steel dead span that your company will be recommending for your proposed truck scale equipment solution. And if the cost of the new steel dead span is not included in your bid submission, please include with your bid submission materials the proposed additional cost(s).

3. Question: On page 8, item 2.2 specifies a capacity of 200,000 lbs. Please clarify.

Response: There are two (2) platform scales in operation now. The intent is to replace these two (2) existing platform scales with two (2) new platform scales. Each individual new platform scale should have a capacity of 100,000 pounds.

4. Question: On page 8, item 2.3 specifies 5lb increments. Please clarify.

Response: Both scales shall have the ability to weigh trucks/vehicles and display those results in 5 pound increments.

5. Question: If 2.2 and 2.3 are true, then the scale would not be legal for trade in Connecticut. Is that a requirement?

Response: The proposed new platform scales will need to be compliant with State of Connecticut requirements. And the proposed new truck scales must also be able to be licensed for operation and use through the State of Connecticut Weights and Measures Office Program. Include with your bid submission a statement that validates that your proposed truck scale equipment is compliant with State of Connecticut requirements and that your proposed truck scale equipment can be licensed for operation and use through the State of Connecticut Weights and Measures Office Program.

6. Question: On page 11, it mentions supply all labor, etc. Items not specified in the bid for concrete walks, etc. Please clarify.

Response: The Town does not believe that any concrete walk work will be required for this project. In the event that your company believes that concrete walk work may be required with your proposed truck scale equipment solution, include within your bid submission an overview of the potential concrete walk work and a detailed estimate of the cost of that concrete walk work.
