- Q1. Regarding the East Street bridge, when was the last time scour analysis was performed? Is the report available?
A1. DOT 2014 and 2016 inspection reports did not include scour analysis.
- Q2. Original construction of the East Street bridge is from 1900 , does the bridge have historical significance?
A2. The bridge is adjacent to a City park. The aesthetics of the bridge will be a consideration of the selection of the bridge structure.
- Q3. Is there a recent Load Rating available for the East Street bridge?
A3. DOT 2014 and 2016 inspections did not include load rating.
- Q4. Regarding the East Street bridge, does the City have any concerns about removing the center pier and making it a single span bridge?
A4. No.
- Q5. Is there a recent Load Rating available for the Mellen Street bridge?
A5. DOT 2014 and 2016 inspections did not include load rating.
- Q6. What is the utility under the Mellen Street bridge?
A6. Utility in question is a water main.
- Q7. Regarding the Mellen Street bridge, when was the last time scour analysis was performed? Is the report available?
A7. DOT 2014 and 2016 inspection reports did not include scour analysis.

- Q8. Regarding the Lake Avenue bridge, is the preliminary Application available?
A8. The preliminary application for all three bridges are available for immediate download from the the City of Bristol website via the following link:
