TOWN OF PLAINFIELD INVITATION TO BID SNOW REMOVAL - *REVISED*

The Town of Plainfield is soliciting bids from an individual or vendor to compliment the Town of Plainfield's snow removal fleet. This will be small areas such as: parking lots, walking tracks, etc.; as specified in the full invitation to bid. The Town will provide sand and salt to the successful candidate. Qualified candidates must be insured and attain all proper equipment.

REVISED Bid packages must be fully completed and signed in order to qualify for the contract. Bid packages can be obtained on-line at www.plainfieldct.org or at the Department of Finance located at 8 Community Ave., Plainfield, CT 06374. Sealed bids, clearly marked "bid-snow removal" will be accepted until 11:00 A.M., Thursday October 17, 2019 by the Finance Director. At that time, bid will be read at an open public meeting. The contract will begin on Oct. 18, 2019 and end on April 30, 2020.

The Town reserves the right to reject any and all bids that are not in the best interest of the Town of Plainfield.

REVISED SPECIFICATIONS FOR SNOW REMOVAL

- I. **SCOPE OF WORK:** The contractor shall furnish all labor and equipment for clearing snow and sanding from areas as specified on the attached sheets during the months of October, November, December, January, February, March and April. Certificate of Insurance showing the coverage shall be filled with the Finance Director on behalf of the Town by the vendor whom earns the contract.

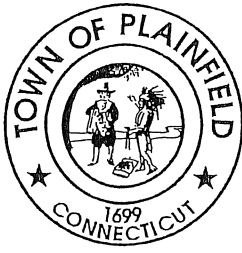
- II. **VISITING SITES:** The Contractor shall be responsible for scheduling site visitations with John Ravenelle of the Plainfield Highway Department.
 - Atwood Fire Station, Wauregan, CT
 - Central Village Fire Station, Central Village, CT
 - Track and Parking Lot @ Town Hall, 8 Community Ave, Plainfield, CT
 - Track and Parking Lot @ Moosup Little League Field, Moosup, CT
 - Aldrich – Moosup Library, Moosup, CT
 - Senior Center, 482 Norwich Road, Plainfield, CT
 - Parking Lot @ Railroad Ave, Plainfield, CT
 - Police Station, Plainfield, CT

- III. **SNOW REMOVAL SERVICES:** Prior to beginning snow removal operations, a successful bidder shall check each site and note with the person in charge of the site any damaged equipment, railings, shrubbery, trees, fences, etc., to establish record for possible obligations and liability claims due to snow removal damage. A successful bidder shall identify meandering sidewalks on the sites that are not well defined, prior to the first snowfall to properly define locations and to protect Town's property.

- IV. **EQUIPMENT:** A successful bidder may be required to prove available possession, by ownership title or lease agreement, the equipment the Town deems necessary for proper removal of snow, before being awarded a contract. The Contractor shall be responsible for arranging supplemental service or labor in case of mechanical breakdown or illness. It shall be the Town's prerogative to reject a bid, if in the Town's opinion, the bidder does not satisfy the requirements of supplemental equipment and personnel.

- V. **RESPONSIBILITY FOR DAMAGES:** Any damage to railings, playground equipment, shrubbery, sod, buildings, pavements, etc. caused by the Contractor or their operators shall be corrected by the Contractor to the complete satisfaction of the Town, prior to final contract payment.

- VI. **SAFETY:** Contractor shall be responsible for all means and methods as they relate to safety and shall comply with all applicable local, state and federal requirements that are safety related. Safety shall be the responsibility of the Contractor.
