There are no included plan minutes. Shared minutes are not available and all plans include voice mail and caller ID. WIRELESS PRIORITY SERVICE (WPS) allows authorized National Security and Emergency Preparedness (NS/EP) personnel to make cellular calls during an emergency when channels may be congested. WPS is the interconnect complement to Sprint Nextel's own Priority Connect service.

WPS is overseen by the National Communications System a division of the Department of Homeland Security. WPS was developed to meet a directive from the White House. NCS executes the program on behalf of the Executive Office of the President. Only individuals in NS/EP positions are authorized to use of WPS. Five categories have been established in order to identify critical NS/EP leadership functions and determine eligibility. Users must apply for and be approved by the National Communication System for Wireless Priority Service. Customers must apply directly to the NCS for Wireless Priority Service and be approved in order for Sprint Nextel to be able to add this service to a number. WPS is for leadership positions only and is not intended for use by all emergency service personnel. Priority Levels are:

- A. Executive Leadership and Policy Makers
- B. Disaster Response/Military Command and Control
- C. Public Health, Safety and Law Enforcement Command
- D. Public Services/Utilities and Public Welfare
- E. Disaster Recovery

Customer must be a Sprint Nextel subscriber. Customer must request WPS service at <http://wps.ncs.gov> or call 1.866.NCS.CALL to apply. NCS will inform Sprint Nextel of those subscribers that are approved for WPS and at what Priority Level. Sprint Nextel cannot add, delete or modify a WPS subscription without NCS consent. Customers may access additional information at <http://wps.ncs.gov/>.

WPS is invoked by dialing *272 prior to the destination number. Wireless Priority Service has a one-time activation fee, a monthly charge, a per minute charge, and additional long distance charges if the customer's rate plan does not include long distance. Use of Wireless Priority Service does not draw down upon cellular minutes in a voice rate plan. Wireless Priority Service does not work outside of the United States.

Sprint Nextel 411 – provides phone numbers, addresses, and directions.

Standard Static IP Address (CDMA) - Allows Customer to purchase a Static IP address to attach to their device.

The service is enabled via the Layer 2 Tunneling Protocol version 3 (L2TPv3) allowing layer 2 traffic to be encapsulated and securely tunneled over the SprintLink IP network. Both dedicated local access and Customer Premise Equipment ("CPE") are required for SprintLink Frame Relay. Unless specifically stated otherwise in this SprintLink Frame Relay pricing section, dedicated local access, and CPE are not included in any of the rates. A. Sprint's Global MPLS VPN offering uses the Sprint IP/MPLS backbone as the transport mechanism. The MPLS protocol is utilized to interconnect the customer network and maintain data privacy. Both dedicated local access and Customer Premise Equipment ("CPE") are required for Global MPLS VPN. Unless specifically stated otherwise in this Sprint Global MPLS VPN pricing section, dedicated local access and CPE are not included in any of the rates. The term "Net" as used in this pricing section means that the associated charge is after any applicable discounts have been applied, but before taxes, surcharges, and other charges otherwise outlined in the Agreement have been applied.

B. **Domestic Bundled Port and Access.** Sprint will charge Customer a fixed Net MRC in the applicable amounts from the product schedule pricing page for each Domestic Sprint Global MPLS VPN "Site". An exclusive Sprint service that extends calling and PBX features and functionality to CDMA wireless devices on the Nationwide Sprint Network. SMI provides end users with the freedom to work virtually anywhere, at anytime.

Sprint customers can leverage SMI to reduce wireless calls to applications traditionally available only from legacy voice services or local access trunks, such as voicemail or audio conferencing. SMI transforms a Sprint customer's mobile device into an extension of their existing service; the Sprint mobile device acts like a desk phone or soft phone.

The CDMA handset obtains all of its features from the application server, giving end users one voicemail box, ubiquitous and standard features, and centralized control of end-user services. Once customers have implemented SMI, they can begin to consider replacing their desk sets with Sprint mobile devices.

3G/4G CONNECTION CARD SERVICES OVERVIEW

Sprint 3G, has average download speeds of 450-800KBPS with peak speeds reaching 3.1MBPS. Average upload speeds of 300-400KBPS with peak speeds of 1.8MBPS are also experienced. 3G peak speeds can be reached when optimum connectivity is established: when near a tower and there are relatively few others using the nearby service.

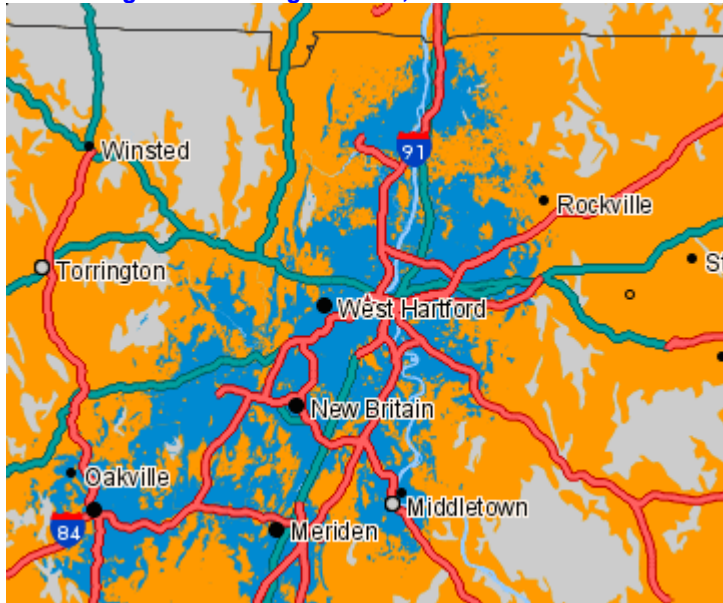
The Sprint 4G Network offers download speeds up to ten times faster than most 3G networks, and with significantly lower latencies, will permit migration from fixed to mobile many delay-sensitive applications, such as Voice Over IP (VoIP), video streaming, video teleconferencing and other business applications that Sprint's users rely on to access critical information in real time.

Sprint 4G, has average download speeds of 3-6MBPS with peak speeds over 10MBPS, and an average upload speeds of 350-500KBPS with peak speeds up to 1MBPS are also experience.

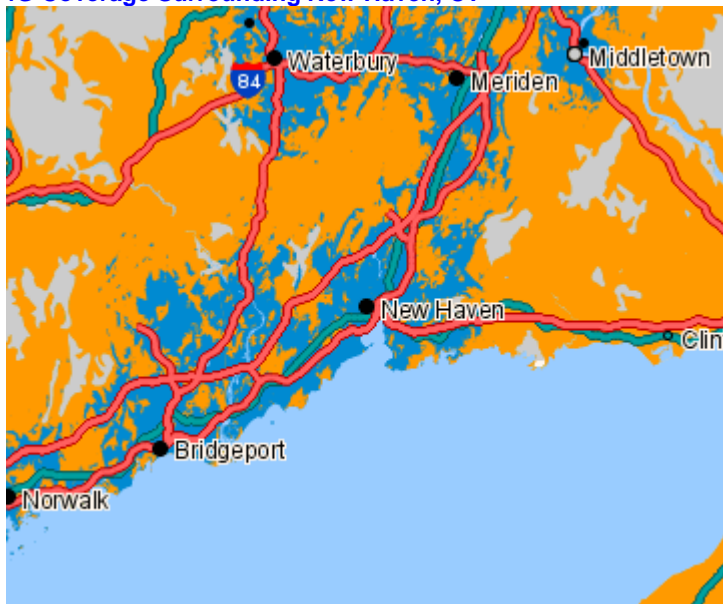
Sprint wireless data Services is not meant to be used: (a) to generate excessive amounts of Internet traffic through continuous, unattended streaming, downloading or uploading of videos or other files or to operate hosting services including, but not limited to, web, or video surveillance; (b) to maintain continuous active network connections to the Internet such as through a web camera or machine-to-machine connections that do not involve active participation by a person.

If Users' data usage on the Sprint 3G Network and the Nationwide Sprint Network in a given month exceeds 300MB while Roaming, Users' will be liable for overage charges. Where the wireless high speed data network is available and a wireless high speed data-compatible device is used, Users' will first attempt to connect to the Sprint 4G Network, then the Sprint 3G Network, and then will default to the Nationwide Sprint Network depending on coverage and network Availability. Roaming is not available on the Sprint 4G Network at this time.

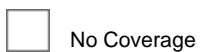
