1. Selection Type:	Contractor Pre-Selection - Minor Capital Projects between \$500,000 & \$1,500,000.
2. General Statement:	In accordance with the requirements of CGS §4b-91(a)(5) (amended by Public Act 14-188), the State of Connecticut Department of Administrative Services (DAS) / Division of Construction Services (DCS) Process Management Unit is advertising this RFQ for the Pre-selection of Contractors for Minor Capital Projects between five hundred thousand dollars (\$500,000) and one million five hundred thousand dollars (\$1,500,000) for a specific DAS Contractor Classification of Work (see Item 3 below).
3. DAS Contractor Classification Of Work For This Pre-Selection:	<p>All prospective Contractors need to demonstrate that they have the necessary qualifications and experience for the following DAS Contractor Classification of Work:</p> <p>Sitework: Work customarily performed by this industry, including earthmoving activities, installation of drainage systems, utility systems and horizontal paving work not requiring mortar.</p> <p>For a full listing of DAS Contractor Classifications of Work, go to this webpage: http://das.ct.gov/fp1.aspx?page=288</p>
4. Cost of Work Range:	Between \$500,000 and \$1,500,000.
5. Project Locations:	Future projects located on State owned property.
6. Project Delivery Method:	<p>Design-Bid-Build (D-B-B): Architect/Engineer (A/E) consultants will be selected (through a different RFQ) to develop design and construction documents (Bidding Documents) for the State to publically bid the Minor Capital Project to only those Contractors who have been Pre-Selected to bid on this DAS Contractor Classification of Work.</p> <p>The Contractor deemed to be the “lowest responsible and qualified general bidder” shall be awarded the contract to build the Project.</p>
7. Objective Criteria for Evaluating Contractors:	Prospective Contractors need to demonstrate that they meet the objective criteria as stated in the 1812 - QBS Submittal Booklet for Contractor Pre-Selection. The QBS Submittal Booklet will be used to evaluate a prospective Contractor’s past performance and experience with comparable work as described in this RFQ’s “ DAS Contractor Classification of Work ”, in a comparable “ Cost of Work Range ”, and will also be used to evaluate other financial, technical abilities, integrity, and absence of conflict of interests. If a Contractor is Pre-Selected to bid on future DAS Minor Capital Projects between \$500,000 and \$1,500,000 , then as a Bidder they shall be evaluated by “ Objective Criteria ” relevant to their project.
8. DAS Contractor Prequalification Certification Requirements:	Contractor Pre-Selection is dependent upon all Prospective Contractors obtaining the DAS Contractor Prequalification Certification for the DAS Contractor Classification of Work by the QBS Submittal Due Date as stated in this RFQ Web Advertisement. 	1	DAS RFQ Web Advertisement: DAS shall publically advertise the RFQ Web Advertisement for Contractor Pre-Selection for a specific DAS Contractor Classification of Work .
	2	QBS Submittal Booklets: Prospective Contractors shall submit their QBS Submittal Booklets in response to the requirements of the RFQ Web Advertisement.
	3	QBS Panels for Contractor Pre-Selection: Three (3) DAS-DCS employees shall be appointed by the DAS Commissioner for each Contractor Pre-Selection QBS Panel . The QBS Panel Members shall jointly evaluate QBS Submittal Booklets from prospective Contractors and prepare a list of Contractors who have been deemed responsible and qualified to be "Pre-Selected to Bid" on Projects for the specific DAS Contractor Classification of Work and submit the list to the Commissioner for approval.
	4	Invitation to Bid – Contractors Pre-Selected to Bid: Only those Contractors "Pre-selected to Bid" for a specific DAS Contractor Classification of Work shall receive an email from the State Contracting Portal notifying them of an Invitation To Bid that requires the services of a Contractor who has been Pre-Selected for the specific DAS Contractor Classification of Work.
