<b>2.</b>	<b>General Statement:</b>	In accordance with the requirements of CGS §4b-91(a)(5) (amended by Public Act 14-188), the State of Connecticut Department of Administrative Services (DAS) / Division of Construction Services (DCS) Process Management Unit is advertising this RFQ for the <b>Pre-selection of Contractors for Minor Capital Projects</b> between five hundred thousand dollars ( <b>\$500,000</b> ) and one million five hundred thousand dollars ( <b>\$1,500,000</b> ) for a specific <b>DAS Contractor Classification of Work</b> (see Item 3 below).
<b>3.</b>	<b>DAS Contractor Classification Of Work For This Pre-Selection:</b>	<p>All prospective <b>Contractors</b> need to demonstrate that they have the necessary qualifications and experience for the following <b>DAS Contractor Classification of Work:</b></p> <p><b><u>Fire Protection Sprinkler Systems:</u></b>            Installation, renovation, repairs and maintenance of fire protection sprinklers in buildings, including such incidental or related work as is customarily performed by those in the Fire Protection/Sprinkler System trades.</p> <p><b>Note:</b> For Contractors to be Pre-Selected for <b>Fire Protection Sprinkler Systems</b> they must have a <b>Fire Protection Contractor License</b> through the State of Connecticut Department of Consumer Protection – see <a href="http://www.ct.gov/dcp">www.ct.gov/dcp</a>.</p> <p>Note: The DAS Contractor Classification of Work can be found on this webpage:  <a href="http://das.ct.gov/fp1.aspx?page=288">http://das.ct.gov/fp1.aspx?page=288</a></p>
<b>4.</b>	<b>Cost of Work Range:</b>	Between <b>\$500,000 and \$1,500,000.</b>
<b>5.</b>	<b>Project Locations:</b>	Future projects located on State owned property.
<b>6.</b>	<b>Project Delivery Method:</b>	<p><b>Design-Bid-Build (D-B-B):</b> Architect/Engineer (A/E) consultants will be selected (through a different RFQ) to develop design and construction documents (Bidding Documents) for the State to publically bid the Minor Capital Project to <b>only those Contractors</b> who have been <b>Pre-Selected</b> to bid on this <b>DAS Contractor Classification of Work.</b></p> <p>The <b>Contractor</b> deemed to be the “lowest responsible and qualified general bidder” shall be awarded the contract to build the Project.</p>
<b>7.</b>	<b>Objective Criteria for Evaluating Contractors:</b>	Prospective <b>Contractors</b> need to demonstrate that they meet the objective criteria as stated in the <b>1812 - QBS Submittal Booklet for Contractor Pre-Selection.</b> The <b>QBS Submittal Booklet</b> will be used to evaluate a prospective <b>Contractor’s</b> past performance and experience with comparable work as described in this RFQ’s “ <b>DAS Contractor Classification of Work</b> ”, in a comparable “ <b>Cost of Work Range</b> ”, and will also be used to evaluate other financial, technical abilities, integrity, and absence of conflict of interests. If a Contractor is Pre-Selected to bid on future <b>DAS Minor Capital Projects</b> between <b>\$500,000 and \$1,500,000</b> , then as a <b>Bidder</b> they shall be evaluated by “ <b>Objective Criteria</b> ” relevant to their project.

		1	<b>DAS RFQ Web Advertisement:</b> DAS shall publically advertise the <b>RFQ Web Advertisement for Contractor Pre-Selection</b> for a specific <b>DAS Contractor Classification of Work</b> .
		2	<b>QBS Submittal Booklet:</b> Prospective Contractors shall submit a <b>QBS Submittal Booklet</b> in response to the requirements of the RFQ Web Advertisement.
		3	<b>QBS Panels for Contractor Pre-Selection:</b> Three (3) DAS-DCS employees shall be appointed by the DAS Commissioner for each <b>Contractor Pre-Selection QBS Panel</b> . The QBS Panel Members shall jointly evaluate QBS Submittal Booklets from prospective Contractors and prepare a list of Contractors who have been deemed responsible and qualified to be "Pre-Selected to Bid" on Projects for the specific DAS Contractor Classification of Work and submit the list to the Commissioner for approval.
		4	<b>Invitation to Bid – Contractors Pre-Selected to Bid:</b> Only those Contractors "Pre-selected to Bid" for a specific DAS Contractor Classification of Work shall receive an email from the State Contracting Portal notifying them of an <b>Invitation To Bid</b> that requires the services of a Contractor who has been Pre-Selected for the specific DAS Contractor Classification of Work.
